

Routed Export Transactions

Dear Valued Customer:

Our commitment at OIA Global is always to strive to make sure that we are fully compliant with all U.S. Government Agencies policies and regulations. As part of our on-going efforts to keep you informed and educated about USA Import/Export regulations, we would like to share with you the Export Clearance regulations for any shipment classified as a "Routed Export Transaction" exiting the USA. The Foreign Trade Regulations (FTR) defines a routed export transaction as

an export transaction in which the foreign principal party in interest (FPPI) authorizes a U. S. agent to facilitate the export of a shipment from the U. S. and to prepare and file electronic export information (EEI).

A Foreign Principal Party in Interest is

the party abroad who purchases the goods for export or to whom final delivery or end-use of the goods will be made. This party may be the Ultimate Consignee.

The U.S. Census Bureau regulations state that all Exports, regardless of mode of transport, shipped from a U.S. Principal Party in Interest (USPPI) to one consignee to a single country of destination, on a single conveyance on the same day, valued over \$2500.00 per schedule B (HTS), or when a license is required and the Cargo is deemed to be a "Routed Export Transaction", will require the Foreign Principal Party in Interest (FPPI) to provide a foreign power of attorney (FPOA) or written authorization to the U.S authorized agent for the Export Clearance or EEI transmission to be filed. If you are going to designate OIA Global as your authorized agent, we will need you to provide us with the FPOA. The FPOA is a blanket authorization good for multiple shipments meeting the criteria above and will remain in full force and effect until revocation in writing is duly given by the FPPI and received by the Authorized Agent.

If you have already designated another party as your authorized agent, we will need them to provide us with a copy of your authorization if they want us to submit the Export Clearance or EEI transmission on your behalf.

Power of attorney to transmit electronic export information foreign princpial party in interest/authorized agent

act as authorized agent for export control, U.S. Census Bureau (Census Bureau) reporting, and U.S. Customs and Border Protection (CBP) purposes. Also, to prepare and transmit any Electronic Export Information (EEI) or other documents or records required to be filed by the Census Bureau, CBP, the Bureau of Industry and Security, or any other U.S. Government agency, and perform any other act that may be required by law or regulation in connection with the exportation or transportation of any goods shipped or consigned by or to the FPPI, and to receive or ship any goods on behalf of the FPPI.

The FPPI hereby certifies that all statements and information contained in the documentation provided, to the authorized agent and relating to exportation will be true and correct. Furthermore, the FPPI understands that civil and criminal penalties may be imposed for making false or fraudulent statements or for the violation of any United States laws or regulations on exportation. However, FPPI understands and acknowledges that Forwarding Agent will not now, or in the future, make any product classification or license requirement determinations on behalf of FPPI and Forwarding Agent will not apply for a license or other authorization on behalf of FPPI.

This power of attorney is to remain in full force and effect until revocation in writing is duly given, by the Foreign Principal Party in Interest (FPPI) and received by the Authorized Agent.
